Chapter 2 § 16 UNLESS BEING JUDGED OR IN THE EXERCISE RING OR PRACTICE RING:
ALL DOGS PRESENT AT THE SHOW SITE MUST BE ON LEASH WITH THE LEASH HELD SECURELY IN THE HAND OF AN ADULT OR HANDLER, OTHERWISE THE DOGS MUST BE CONFINED TO THEIR CRATES

Special training devices that are used to control and train dogs, including but not limited to, collars with prongs, electronic collars used with transmitters, muzzles and head collars may not be used on dogs at AKC events, except as allowed in the AKC Rule, Regulations and Policies.

Notice to Exhibitors

- **UNSIGNED ENTRIES CANNOT BE ACCEPTED.** Entries not on Official AKC Entry Forms and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.
- **NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.** Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.
- **POST DATED CHECKS, RETURNED CHECKS** do not constitute a valid entry fee. The Secretary will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis,
- **NO REFUND FOR DUPLICATE ENTRIES.** Every effort to find all duplicate entries will be made; however, if the entry has been processed, no refund will be made.
- **DOGS MAY ARRIVE** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.
- **JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.
- **ALL DOGS PRESENT MUST BE HELD ON LEASH OR CONFINED TO THEIR CRATES** except when being judged. Prong collars and other training collars are not to be used on the show site.
- **CLASS CASH PRIZES** will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that Show is over, and the Secretary advised at once. The Secretary and show-giving Club disclaim any liability for cash prizes after the judging of the breed is over.
- **ALL PRIZES** must be claimed at the show . . . If not, they become the property of the Show Giving Club.
- **NO PRIZES** will be mailed.
- **MINNEAPOLIS KENNEL CLUB, INC, RESERVES THE RIGHT** to substitute prizes with ones of equal or greater value..

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
4. Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above.
